Wipfli merges in Howe, Riley & Howe

Wipfli, a Top 100 Firm based in Milwaukee, has expanded its footprint in New England by adding Howe, Riley & Howe, a firm based in Bedford, New Hampshire, effective Jan. 1, 2019.

The accounting and consulting firm Wipfli has acquired the partners and staff of New Hampshire-based Howe, Riley & Howe, marking Wipfli's second expansion in New England in six months.
